## Amendment to the Gore District Plan

This notice is to advise that the Council has approved the reclassification of residential and industrial zoned land in Mataura, and residential, industrial, mixed use and commercial zoned land in Gore. It will be classified as Urban Environments, in accordance with the National Policy Statement on Urban Development 2020 (NPS-UD).

To give effect to Policy 11 of the NPS-UD, the Gore District Plan will be amended to remove the minimum on-site parking rates within the Urban Environments described above.

This notice is in accordance with Resource Management Act 1991 - Clause 2A Section 55.
