Thank you for your information requet on Thursday 23 May regarding the death of Lachlan Jones at the Council's oxidation ponds in 2019.

You requested all of staff email/s sent about the child's death and want to do about WorkSafe.

The Council conducted a search of its email archives, from 29 January 2019 to 4 June 2024, for the addresses All Staff, All Staff and Contractors, and All Admin Building Staff.

The key words were 'oxidation ponds' or 'Lachlan Jones', or 'drowning' or 'Worksafe" or 'Lachie Jones' or 'Lachlan' or 'Lachie'.

This search resulted in only two emails, which are attached.

## Hi Everyone,

It is with a very heavy heart that I advise last night a three year old boy drowned in the Gore Oxidation Pond. The boy apparently disappeared from his residence with the Police and Search and Rescue being alerted.

This is an absolute tragedy and my deepest sympathies go out to the family for what can only be described as an incalculable loss. The relevant authorities have been notified and the Council will be working closely with them.

In the meantime I have instigated an urgent review of security fencing at the ponds.

I know this message follows sad news about one of our staff member's family being the subject of a search and rescue operation on the south coast. If any staff member feels they need some emotional support, given this awful news, please get in touch with your Manager or me.

WorkSafe notified the Council recently that it intended to lay charges under the Health and Safety at Work Act 2015 and these have now been filed with the court.
