WATER BYLAW 2015 – AMENDMENT No 1, 2018



Amendment to the Gore District Council Water Bylaw 2015 made in pursuance of the powers contained in the Local Government Act 2002, and pursuant to all other powers, authorities and provisions contained in any other Act enabling the said Council in that behalf:

1. Short Title

The short title of this amendment shall be the Gore District Council Water Bylaw 2015, Amendment No 1, 2018.

The amendment shall come into operation on the 15th day of January 2019.

2. Amendment to clause 3.4 - Types of supply

3.4.3 Metering

4. Before a meter can be fitted under sub-clause (2) above, the Council must serve a notice on the customer that it has reasonable grounds for believing that the water use on the customer's premises is excessive. The Council shall request that the customer act to ensure their use is not excessive, within 10 working days, failing which a meter may be installed.

3. Amendment to clause 3.6 - Continuity of supply

3.6.3 Demand management

- (a) The customer shall comply with any restriction on the use of water from the Council's reticulated systems in Gore and Mataura to manage high seasonal or other demands that may be approved by the Council pursuant to section 151(2) of the Local Government Act 2002.
- (b) Such restrictions will be publicly notified by the Council.
- (c) When such restrictions apply the Council will take all practicable steps to ensure that an adequate supply of drinking water is provided to each point of supply.
- (d) In managing water demand and setting water use levels the Council will take

into account:

- (i) the level of usage by consumers;
- (ii) the availability of water from Council supplies;
- (iii) the scale, significance and potential duration of any breakages in the reticulated network that could impede supply to consumers;
- (iv) seasonal weather conditions including recent rainfall and the prospects of rain;
- (v) the usage of water compared to the levels in the council bores, the flow in the Mataura River measured at Gore in conjunction with resource consent conditions; and
- (vi) restrictions applying to other consent holders.
- (e) The Council has water use levels to manage the water use at sites_connected to the Council's reticulated water supply. Any decision to change the water use levels applying at any time will be made by the Chief Executive of the Gore District Council and will be publicly notified. The levels are set out in Schedule 5, attached.
- (f) The water use levels referred to in sub-clause (e) above do not apply to:
 - i. water stored in rain water tanks which are not supplemented by the Council supply; and
 - ii. water sourced solely from bores not connected to the Council's reticulated systems
- (g) When restrictions are in place, only ONE external tap and watering device may be used on a property. If two external water taps are available on a property only one may be used as any one time.
- (h) When flow in the Mataura River, as determined at the Environment Southland's Gore monitoring site, falls to, and remains at or below 17 cubic metres per second, the Council shall, if it has not already done so, issue a public notice requesting water conservation by all consumers supplied with water from the Gore reticulation system.

4. Amendment to clause 3.8 - Fire protection connection

3.8.3 Fire protection connection metering

(b) Where an unmetered connection has been provided to supply water to a fire protection system this shall be used for no other purpose than fire fighting and testing the fire protection system except where the fire protection system is installed in accordance with New Zealand Standard (4517:2002 Fire Sprinkler Systems for Houses);

The foregoing amendment was duly adopted at a meeting of the Gore District Council's Emergency Committee held on the 14th day of January 2019 and ordered to come into force on the 15th day of January 2019.
